SUPPLEMENTARY REGULATIONS

Poznań, 26 – 29.07.2012 r.

1. Announcement and Jurisdiction

The Automobilklub Wielkopolski on behalf of PZM will organise the UEM Alpe Adria Championship, European Championship Qualification at the „Poznań” circuit.

This event will be held in accordance with the Alpe Adria Motorcycle Union – Road Racing Regulations 2012 and these Supplementary Regulations.

Simultaneously with UEM Alpe Adria Championship races of the following series will be held: Polish Road Racing Championships, Czech Republic Championships, Slovakia Championships and Polish Cup and Czech Republic Cup races.

4. The Race Office

The Race Office will be open on 26.07.2012 at hrs. 10.00 - 18.30 . In the remaining days of competition in accordance with the time table. The Race Office is situated on the ground floor of the control tower (entrance from the paddock/parking side).

5. Entries and entry fee

The first closing date for applications expires on the 12th of July 2012 at 24.00 hrs. Second closing date for applications is on the 27th of July 2012 at 19.30 CET.

Applications can be send by regular mail, e-mail or fax, in accordance with address data from point 2 these Supplementary Regulations.

Accepted licences – apart from FIM licence – national licences of all UEM Federations with the valid insurance and FNM starting permission.

Entry fee for the event:

A) Alpe Adria 125SP, 125GP, SST600, SST1000, SSP, SBK

- 1st closing date - 180 euro / 810 pln
- 2nd closing date – 250 euro / 1125 pln / per class
- for starts in two classes – 310 euro / 1395 pln

B) WMMP – surcharge for Saturday's race of Polish Championships – 45 euro / 200 pln

C) Rookie 600 and 1000; Czech Open 600 and 1000

- 1st closing date - 100 euro / 450 pln
- 2nd closing date – 150 euro / 675 pln

D) 125 Polish Junior Cup (only PL)

- 1st closing date - 100 pln
- 2nd closing date – 150 pln

E) Pretendent (only PL) – 450 pln

Entry fees at the event will be accepted in Race office. Payment in cash only (Euro or PLN), credit cards will not be accepted.

6. Circuit

The races will be held at Poznań circuit. The length of one lap of the track is 4,083 meters and its width is 12 m. All races will be run clockwise (a drawing of the circuit is enclosed).

The maximum number of riders allowed ia as follows:

- ♣ 53 motorcycles in a practice

- ⤴ 44 motorcycles in a race

7. Practices

Fee for Supplementary Practice (SP) is:

- ⤴ 1 SP – 120 PLN (€ 30)
- ⤴ 2 SP – 220 PLN (€ 55)
- ⤴ 3 SP – 300 PLN (€ 75)

Sticker for each session which is authorizing participation in the SP should be affixed on windscreen on the right side.

Participants of the SP may only ride in their class sessions, the class in which they registered.

8. Technical scrutineering

Technical scrutineering will be held in tent, located next to the Press Office accordingly with the time table of the event.

Application for technical scrutineering should first be completed legibly and signed by the competitor.

On the technical scrutineering rider is obliged to appear in the suit, back protector and helmet.

Transponders will be distributed at the Technical Scrutineering (free of charge). As a deposit for the transponder, rider or his mechanic must leave the document confirming their identity. In the case of loss or destruction of the transponder rider will be charged 1 200 PLN or € 300 (one thousand two hundred PLN or three hundred EURO).

9. Fuel

It is impossible to tank fuel at the "Poznań" circuit. The nearest petrol station is located in Przeźmierowo, Rynkowa Street of about 1 km from the entrance gate to the racetrack.

10. Race

Races length:

- ⤴ 125SP – 9 laps
- ⤴ 125GP - 9 laps
- ⤴ Superstock 600 - 15 laps
- ⤴ Supersport - 15 laps
- ⤴ Superstock 1000 - 16 laps
- ⤴ Superbike - 16 laps
- ⤴ Rookie/Czech Open – 10 laps
- ⤴ 125 Polish Junior Cup – 7 laps
- ⤴ Pretendent – 7 laps

Competitors are required immediately after the race to leave their motorcycles at the disposal of the Technical Commission, in a place designated by the Organizer.

Decoration of the winners of individual races will be held immediately after their finish.

11. Medical Center

The location of the Medical Centre is pointed on the attached circuit plan.
The CMO decides upon whether a rider is fit or not, especially after each fall. Therefore **each rider must be checked after an accident by the CMO** without any additional order. Otherwise the rider will be excluded.

12. Environment protection

Each rider is responsible for his and his teams waste. Containers for waste must be used following their specification. It is strictly forbidden to leave any waste. Cleaning of vehicles with fuel or other solvents is prohibited. The ground in the paddock cannot be damaged from oil, fuel or other liquids.

Penalties against this will be issued in accordance with the Sporting Code. The organizer has the possibility to request return of all costs which may arise as a result of behaviour against the FIM Environmental Code.

It is forbidden to start competition bikes between 07:30 pm – 07:30 am.

13. Insurance

By endorsing the application form for entry the FMN of the rider certifies that the rider is insured in accordance to the FIM requirements.

In comfort with Art. 110.1 of the Sporting Code, third party insurance in respect of riders covering accidents occurring during the event including practices will be responsibility of the organiser.

Every rider must have a private accident insurance, which shall be shown at the administrative check.

The organizer disclaims all responsibility for damage to bike, its accessories and components.

14. Additional Regulations

At 10.30 am on Sunday all riders and mechanics are invited to take part in the ceremonial opening at the depo. Immediately after the opening souvenir photos of all the Alpe Adria Championship competitors will be taken on the start-finish line.

The curfew is between 22.00 – 6.00.

All penalties imposed must be paid at least 30 minutes before the next start (training, race), otherwise rider will not be allowed to take part.

At the administrative checks each rider will receive 4 personal passes (1x rider, 3x mechanic) and 1 car pass to enter the paddock and depot (team receives the appropriate multiple passes depending on the number of riders in the team). Additional passes can be bought in the event office – 15PLN / 5 Euro /pass. All passes must be worn visibility during the stay at the circuit.

In the 2011 season it is not possible to rent boxes along the depot. We have a paddock with 5000m² paved surface. **You can set your tent after having sent the dimensions of the tent/set to: moto@aw.poznan.pl**

Animals in paddock must be kept on a leash. It is strictly forbidden to bring animals to the depot.

Competitors must leave the paddock by 21:00 on Sunday.

The Organiser reserves the right to issue additional messages, and proper interpretation of

these Regulations.

Additional informations:

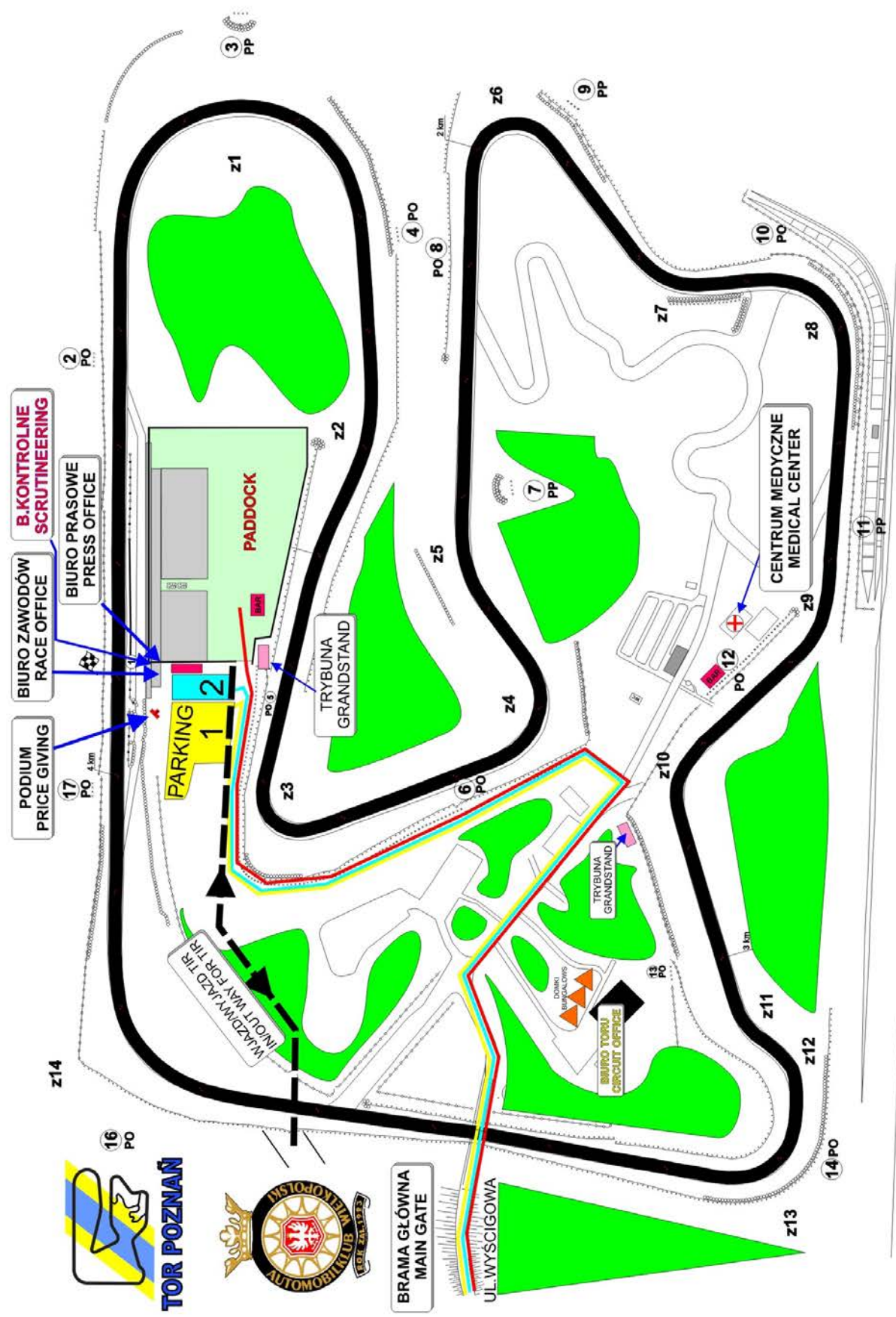
1. It is forbidden to drill holes in the pavement blocks in the pits
2. For not obeying the rules by the rider or member of his team, the organizer may impose financial penalties, up to 500 PLN (€ 125):
 - ⤴ burn-out of the rubber on circuit– 300 PLN (€ 75)
 - ⤴ disturbing the curfew - 500 PLN (€ 125)
 - ⤴ drill a hole in the pavement blocks - 20 PLN (€ 5) per hole
3. Free entrance to the paddock for participants starts from 25th of July 2012 from 18.00. Between 00.00-06.00 entry to Circuit "Poznań" will not be possible.
4. Cars shall be parked only on a specially designed car park (prior to entry into the paddock).
5. Automobilklub Wielkopolski has small hostel like infrastructure:
 - ⤴ 3 bungalows BRDA wc (6 prs.) – 335 PLN / (€ 85) night
 - ⤴ 4 double rooms wc+tv – 123 PLN / (€ 30) night
 - ⤴ 3 tripple rooms wc+tv – 200 PLN / (€ 50) night
